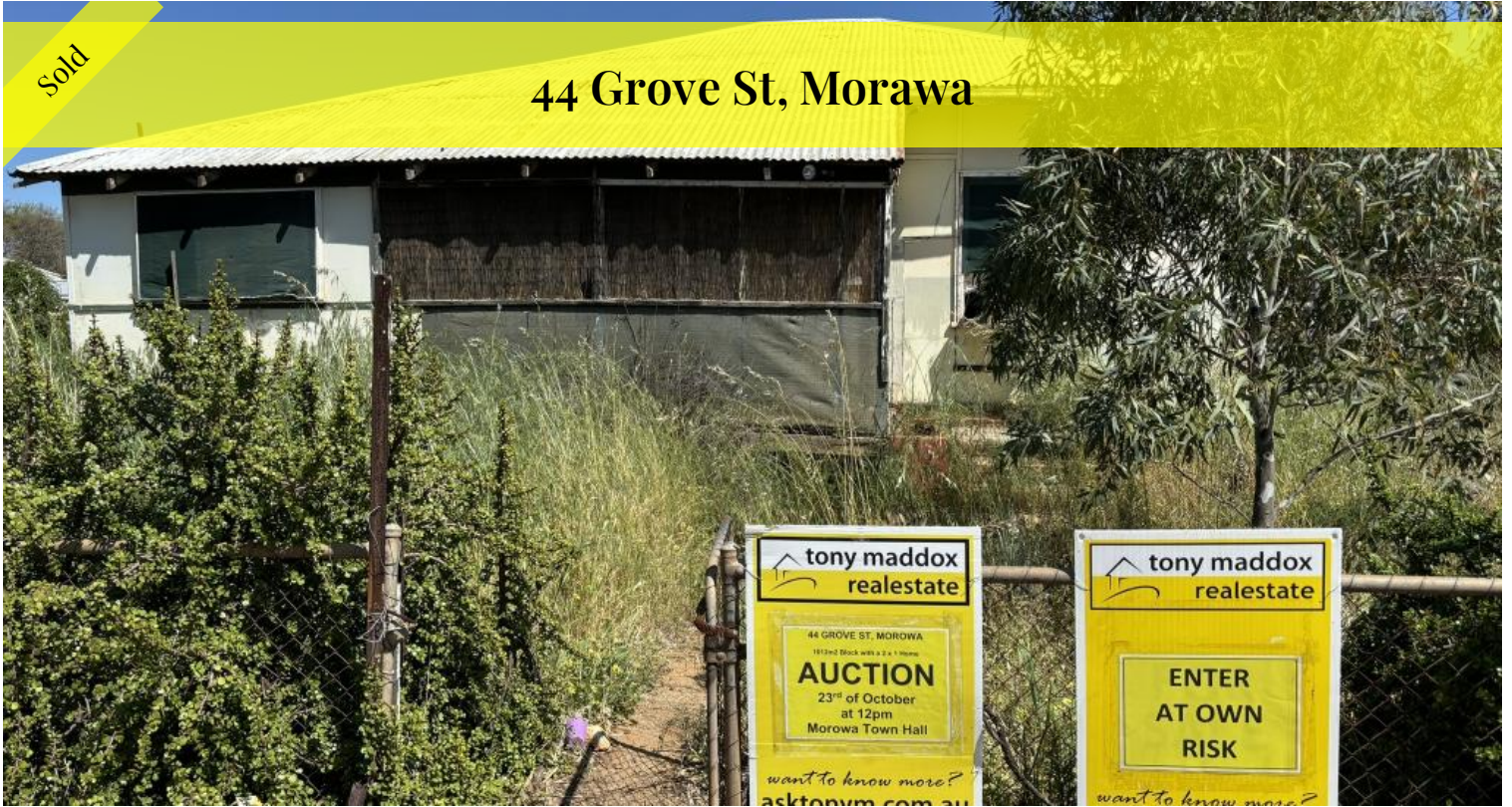

**HEALTH NOTICE – UNFIT FOR HABITATION - LOT 296 (844) GROVE STREET, MORAWA**

This is to advise you that the Shire's Environmental Health Officer, Mr Peter Toboss conducted an inspection of your property located at 44 Grove Street, Morawa on 17 September 2024, following complaints regarding dilapidated condition of the dwelling.

The inspection revealed the following health issues relating to the dwelling -

- The derelict state of the house, specifically:
  - evidence of rusted, broken gutters and downpipes;
  - rusted, dilapidated corrugated iron roof cladding;
  - damaged, broken and peeling off asbestos sheet exterior wall cladding;
  - the internal ceiling having collapsed in sections;

Tribunal for a review of the decision in accordance with the State Administrative Tribunal Act 2004.
